#### b. Legislative Update for May 2023

Matt Abbott presented the Legislative Update for May 2023. Matt explained that the Legislative Session is headed towards a special session. David Dunn explained how the special session worked. The only bills right now can be conference committee reports meaning that they are bills that have been voted on in the house and moved to the senate and passed in the senate with minor changes. Special session is driven by the Governor, when the legislative session meets. David explained that the school safety bill has a high chance of getting through before the special session and there will be funding for that. Francisco Garcia explained that the big topics for the special session are funding and safety. School funding won't be decided until as late as September.

# d. Fundraising and Enrollment Update for FY 23 &24

Martriza Gladyn presented the Enrollment Update. Wayside ended the school year with 1680 scholars. The withdrawals that are currently happening are due to people moving. There are still 208 applications that need to be completed. Pre-K 4 classes have been added to both AMA and EPA. This is the first year that Wayside has had a Pre-K/K roundup so that families could fill out paperwork. Enrollment continues to be on target for Fall 2023.

Elizabeth Wrona presented the Fundraising Update. She explained that Wayside received \$25,000 from the Webber Foundation for transportation. 8 scholars in the STHS Class of 2023 have been awarded \$16,000 in Scholarships from Wayside Schools Foundation and a grant has been submitted to the Cigna

Foundation for Wayside Pre-K Programs. There is a new grant opportunity in the works for Travis County RFP for Youth Development Services and there is a grant that is being submitted to Texas Mutual EOM.

# Chief Academic Officer Update

#### a. May Academic Report and Action Plan

Susan Pommerening presented the May Academic report. She presented the list of dates for when Wayside will receive the data. May 22 was when the first round of data came and it was a prediction of if the student will pass, fail or fall into the range of uncertainty. On August 11 is when Wayside will receive the scores and the performance letter that can be used to estimate ratings, this is about 2 months later than normal.

Marcia Mollinar presented about recruitment. Matt Abbott explained that Marcia is the new Chief Talent Officer. There are three people working on recruitment. There are more people applying for jobs. Marcia thinks that there will be more experienced teachers applying. Elaine Candalas asked how many job openings that Wayside has. Marcia explained that there are 75 openings and at the end of this week there are 45 applicants.

### **Chief Operating Officer Update**

#### a. Statement of Activities as of 4/30/23

Francisco Garcia presented the Statement of Activities. The budget is 83% complete and revenue is tracking a little above 83%. This is due to IRS credits at the beginning of May and fundraising from the Gala. Expenses are tracking at 85%. Transportation is a little high, this is due to the vendor increasing bus driver rates to maintain drivers. Operations are running a bit high for physical plan repairs as well, but, overall the budget is trending as expected and in the net positive.

## b. School Safety Updates

Francisco Garcia presented the School Safety updates. He is currenting reaching out to constables for possible contracts if the School Safety bill passes in the legislative session to have access to armed staff as needed.
