Matt Abbott presented the Legislative update. There is a school funding bill that is moving into the House. This bill isn't expected to go through as passed and there are expected to have a lot of amendments. The amendments are expected to negatively affect Charter Schools. If this bill does pass, it will be a sufficient amount of funding towards schools.

b. Fundraising and Enrollment Update for FY 24

Maritza Gladyn presented about Enrollment. Enrollment is stable around this time of year. There are 25 applications that are open and 40 applications for the 2024-2025 school year that are mainly Pre-K 3 and Pre-K 4. There are 250 families signed up for Coats for Kids.

Elizabeth Wrona presented about fundraising. Texas Mutual Awarded Wayside Schools \$85,000. There were \$115,000 in grants submitted in October. The 4<sup>th</sup> Annual Giving Tree has launched.

c. School Safety Updates and Possible Actions and Resolution(s) for HB 3 Compliance/ School Safety

Cameras are up and running at William Cannon and enhancing the cameras at Eden Park. Safety film is on hold and will be done by winter break. William Cannon and Bradshaw will be done first and Eden Park will be done last because some windows will be replaced.

a. Statement of Activities as of 9/30/2023 & 10/31/2023

Francisco Garcia presented the Statement of Activities. The budget is 33% complete. The revenue is at 31% complete. Fundraising is low but will increase as soon as the funds from KLE and Texas Mutual come in. The Curriculum expense is trending high since we buy the curriculum at the beginning of the year. Instruction leadership expense is trending high due to adding a new instruction leadership position and will be in the budget amendment. Debt services are for the first six months. Debt service is paid twice a year, once in September and once in February.

b. Financial Audit for FY 23

Shawana Spann presented the Audit for FY 23. For the 2023 Audit, it is a clean opinion on the financial statements. There was an adjustment for bond interest. There was an audit on the school compliance. There were three major programs to audit this year.

Jesus Becerra motioned to accept and approve the Audit for FY 23 and seconded by Nicole Trevino seconds, a roll call vote was taken, and the motion passed unanimously.
