Chief Executive Officer Update

Chief Executive Officer Update, Discussion, and Possible Action on:

Board Members, Term Update and Transitions (Sembello and Bacerra)

Meredith Sembello and Jesus Becerra intend to roll off the board at the end of the fiscal year at the end of their term. The board recognized Meredith and Jesus for their service and wished them all the best in the future.

Legislative Update

Matt Abbott provided an update to the board on legislation concerning school finance naming that there were multiple bills focused on increasing school funding that seem promising. At this time nothing is passed and the board will continue to get updates each month as the session concludes.

Fundraising Update

Liz Wrona gave a presentation to the board on fundraising year to date providing a report on the impact of the gala. At this time, Wayside has now raised over \$300K towards its fundraising goals for the year with a target of \$750k which is currently behind. There are a number of asks and grants out and the team is hopeful that some will close prior to the end of the fiscal year.

School Safety Updates and Possible Actions and Resolution(s) for HB 3 Compliance and School Safety: Clint Wise provided further clarity on the Good Cause Exception Statement for Private Security in Lieu of Peace Officer, this is a revisiting of the statement from the prior month. He ask for the board to consider revising their previous statement to clarify that the school will use the good cause exemption and will hire a private security firm in lieu of starting a police force.

Elaine Candelas asked for a motion to approve the Good Cause Exception Statement.

Jesus Becerra made a motion to approve the Good Cause Exception Statement as presented, Dr. Ruth Reinhart seconded, a roll call vote was taken and the motion passed unanimously.

Superintendent Performance Review, Monitoring and Contracting for 25-26 (Executive Session):

Update on Academic Accountability for SY23 and SY24 based on recent court decision

Susan Pommerening provided an update on the impact of the recent legal decisions concerning 22-23 and 23-24. Through legal decision TEA is now free to release the 22-23 Accountability ratings, and as a result it is expected that they will also soon be able to release the 23-24 ratings.

While Wayside has been transparent on our internal rating expectations in our community, ratings would now be made publicly available.

April Academic Update on Student Performance and Programs

Susan Pommerening provided an update on academic performance on common assessments. She shared concerns in targeted areas at Middle school and High School, while more general concerns at Altamira Academy. Despite these concerns, at this time Wayside still looks to be in a position to increase its accountability for the network.

Chief Operating Officer Update

Chief Operations Officer Update, Discussion, and Possible Action on:

24-25 Enrollment:

Similar to last month, Karlie Ramirez presented on current enrollment trends and activities stating that enrollment is hovering around 1,800 scholars. Enrollment continues to backfill openings and enrollment. There are also about 360 applications for the 2025-26 school year in process now

Statement of Activities as of 4.30,25:

Francisco Garcia reviewed the statement of activities as provided in the board materials. Like in last month's presentation, Wayside continues to operate in a deficit due to serving fewer students than originally budgeted for as presented in previous meetings, but shared that budget reduction strategies continue. Wayside continues to be on track to pass FIRST and meet all bond covenants.

Teacher Pay Scale and Stipends for SY 2025-2026

Francisco Garcia presented an unchanged teacher pay scale for SY 25-26, calling for a pay freeze for all Wayside staff until there is further clarity from the legislative session budget bill, not expected until June, with further clarity coming in the month of July from TEA. The board supported revisiting this pay freeze, while also adopting limited changes to stipends for special education teachers.

Elaine Candelas asked for a motion to approve the Teacher Pay Scale and Stipends for SY 2025-2026 as presented by staff.

Paul Duchene made a motion to approve the Teacher Pay Scale and Stipends for SY 2025-2026 as presented by staff, Meredith Sembellow seconded, a roll call vote was taken and the motion passed unanimously.

Elaine Candelas asked for a motion to renew the contract for the 25-26 SY with the superintendent with the stipulations she listed, with the superintendent having met standard on his appraisal.

Dr. Nicole Trevino made a motion to renew the contract for the 25-26 SY with the superintendent with the stipulations provided by Eliane Candelas, pending final legal review from counsel, Meredith Sembello seconded, a roll call vote was taken and the motion passed unanimously.
